NEW BUSINESS:

Solicitor Statement: Executive session was taken to address a disciplinary issue regarding Zoning and Sewage Office Robert DiLorenzo; a hearing was offered in accordance with the Procedures Manuel. Pursuant to that Manuel and State Law, Mr. DiLorenzo had an option of a public or private hearing, both were declined, and a decision was held in executive session.

- **Motion** to suspend Robert DiLorenzo from his position of Zoning and Sewage Officer for two weeks from April 6, 2015 to April 20, 2015 with a disciplinary letter placed in his personnel file, and appoint Chris Woods for Zoning and Sewage at the rate of \$27.59, **made by Supervisor Raser, second by Chairman Fluhr, motion carried.**

PUBLIC COMMENTS:

Carrie Thomas: Has merit been given to the broader issue of falsification of public records?

Solicitor: What was discussed in executive session is private. Solicitor advised the board not to disclose the specific reasons why the disciplinary action was taken.

Robert DiLorenzo: Publically apologized to Cherie Graber for acting inappropriately and it was a mistake on his part.

Cherie Graber: Questioned the Board as to who designed the septic system located at the Township Garage since the design states JWE designed the system, and she knows that Jason did not design it.

Solicitor: The open records give you the vehicle to find out information that is necessary for the township to address your concerns. Solicitor also advised that Mrs. Graber put her concerns in writing so this Board can properly address them.
